JOB DESCRIPTION: Under the direction of an appropriate supervisor in a state correctional institution or facility, assumes a caseload on an appropriate number of inmates, and provides counseling, assessment, program planning services to these individuals, as well as aid in informational and situational problem solving; may handle the more complex, difficult cases; does related work as required.

More specifically, the selected candidate shall serve as the program social worker on a Veteran's Unit within East Jersey State Prison, where they will be responsible for facilitating psycho-educational and therapeutic programming and providing case management services. Although not required, the preferred candidate shall have Veteran status, in an effort to best comprehend the specific needs of incarcerated Veterans.

REQUIREMENTS

EDUCATION: Graduation from an accredited college with a Master's degree in Social Work.

EXPERIENCE: One (1) year of experience in social case work, which shall have involved the responsibility for gathering and analyzing social information from clients, the determination of their needs, and the planning and administration of treatment plans geared towards the needs of individual clients.
