DEFINITION: In the Department of Military and Veteran Affairs, at the NJ Veterans' Memorial Home at Vineland, under the direction of an Engineer-in-Charge of Maintenance, or other supervisory official in a state department, institution or agency has charge of the power and heating plant where capacity of equipment involved does not exceed 1000 boiler horsepower, and/or which may include major air conditioning units; does other related work duties.

REQUIREMENTS:

EXPERIENCE: Three (3) years of experience in work involving the operation, maintenance and emergency repair of power and heating plants and auxiliary equipment.

NOTE: Appointee will be required to possess an Operating Engineer's License (Blue Seal Minimum) issued by the NJ Department of Labor and Workforce Development.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform to essential duties of this position.
