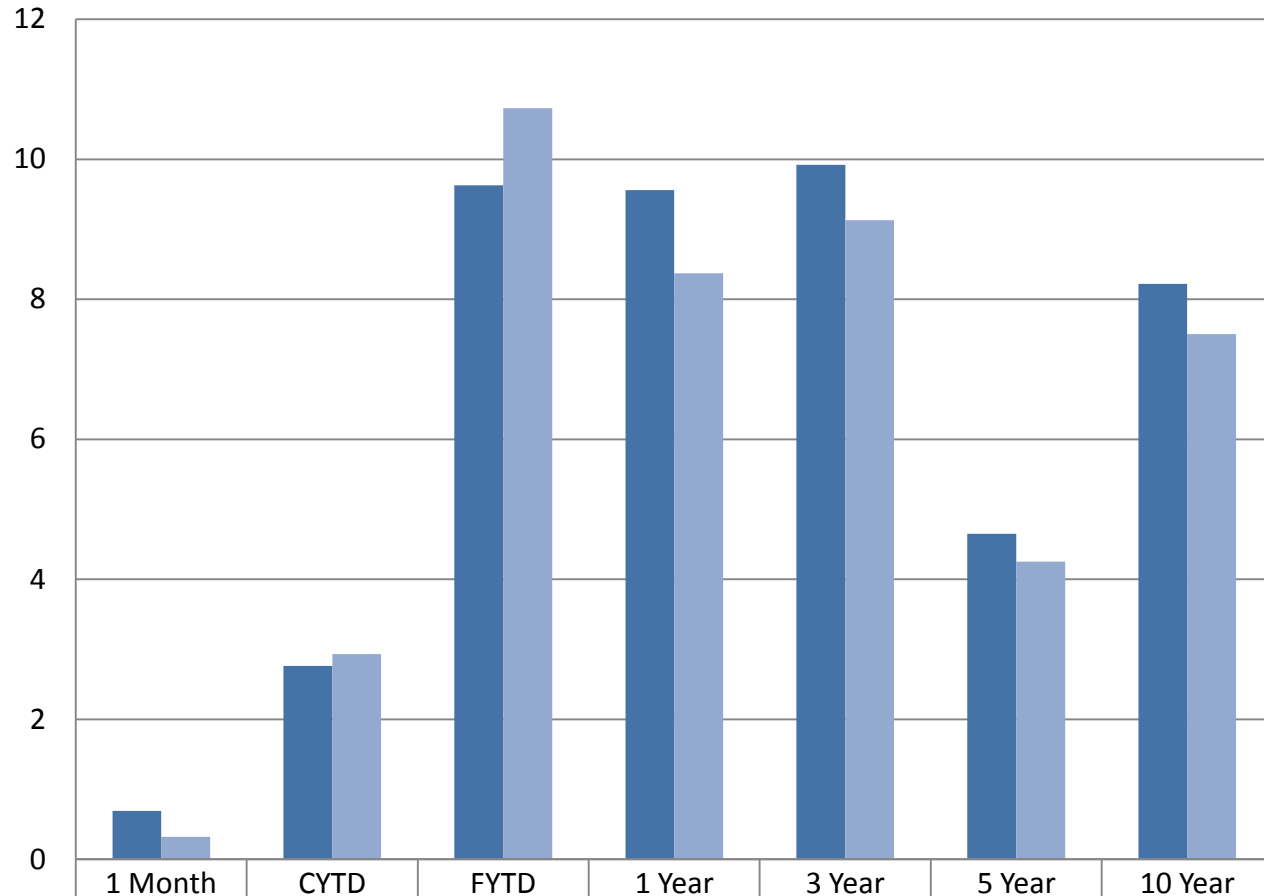

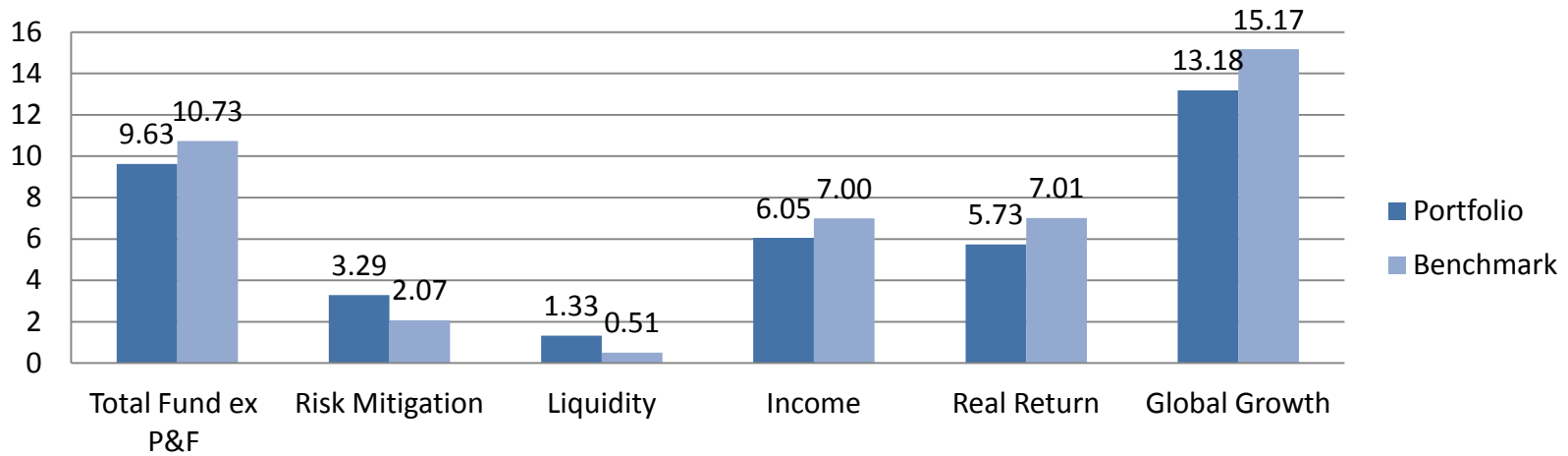
Total Fund ex Police and Fire Mortgages as of 2/28/13



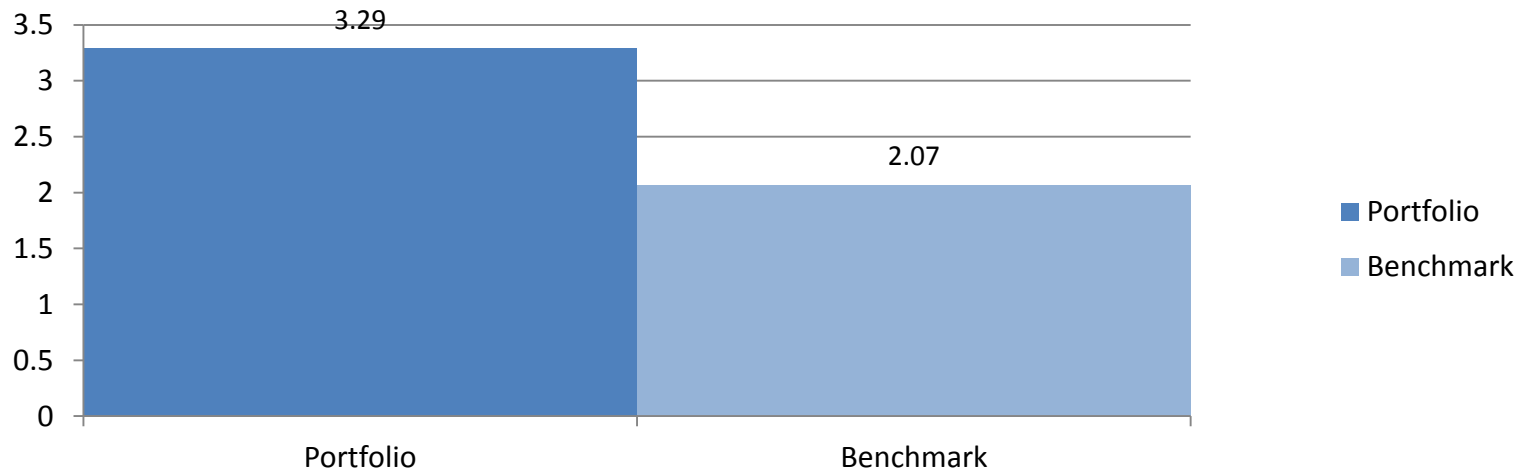

FYTD Performance by Asset Class as of 2/28/13

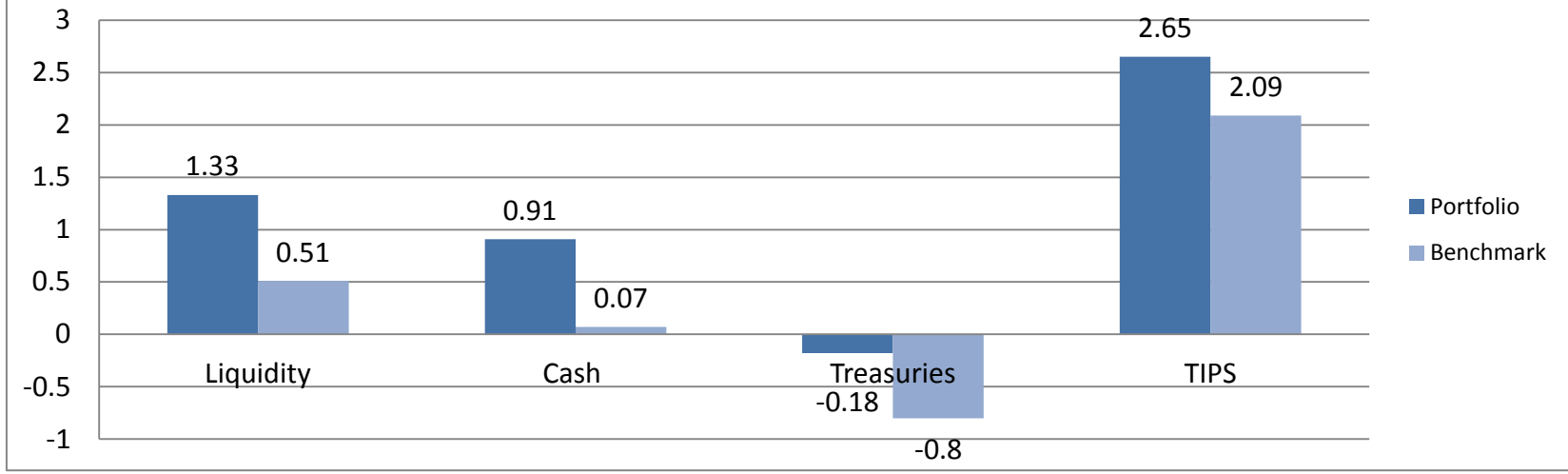


FYTD Risk Mitigation Performance as of 2/28/13

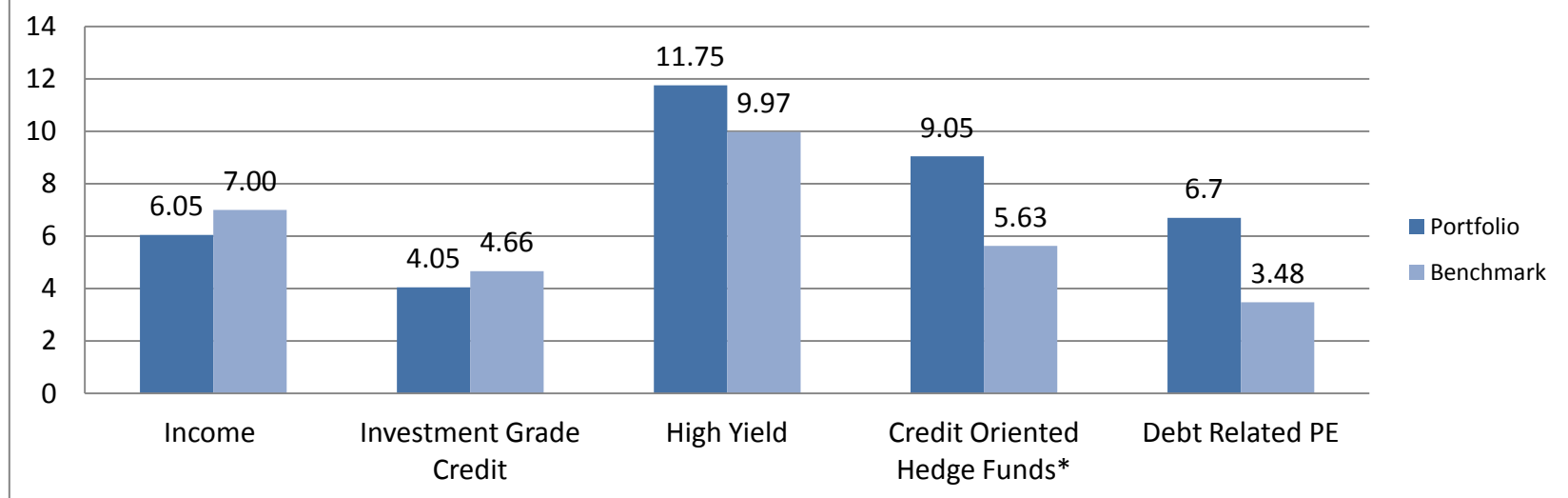

FYTD Liquidity Performance as of 2/28/13

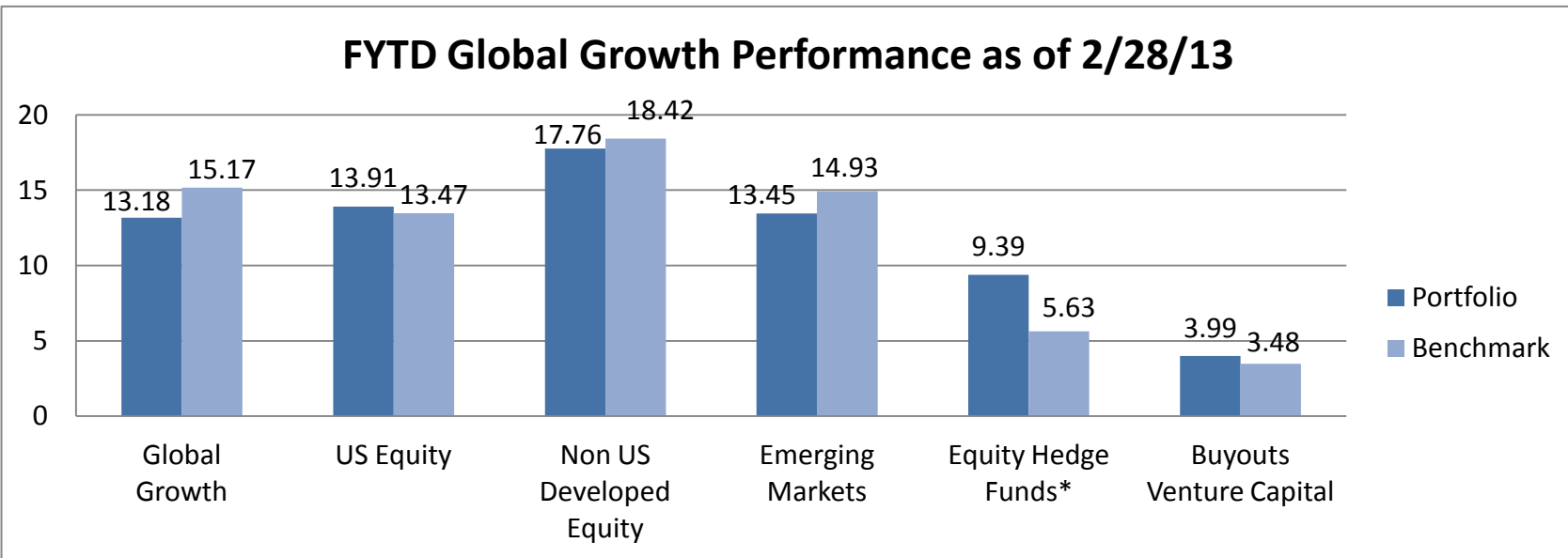
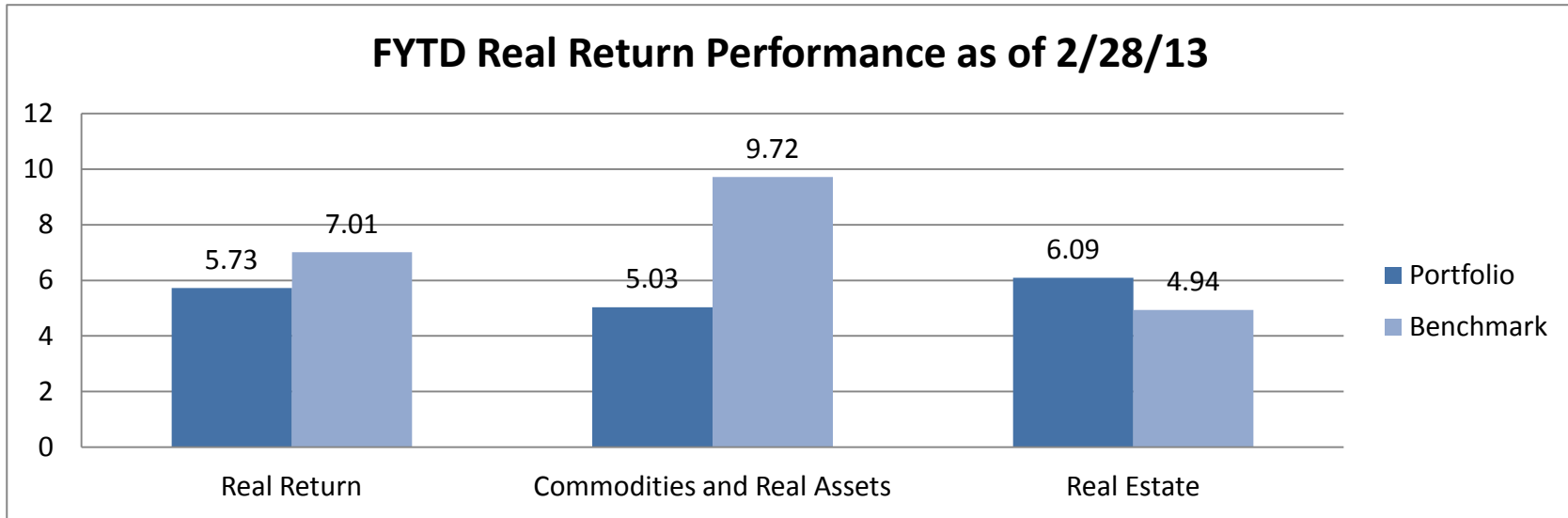


FYTD Income Performance as of 2/28/13

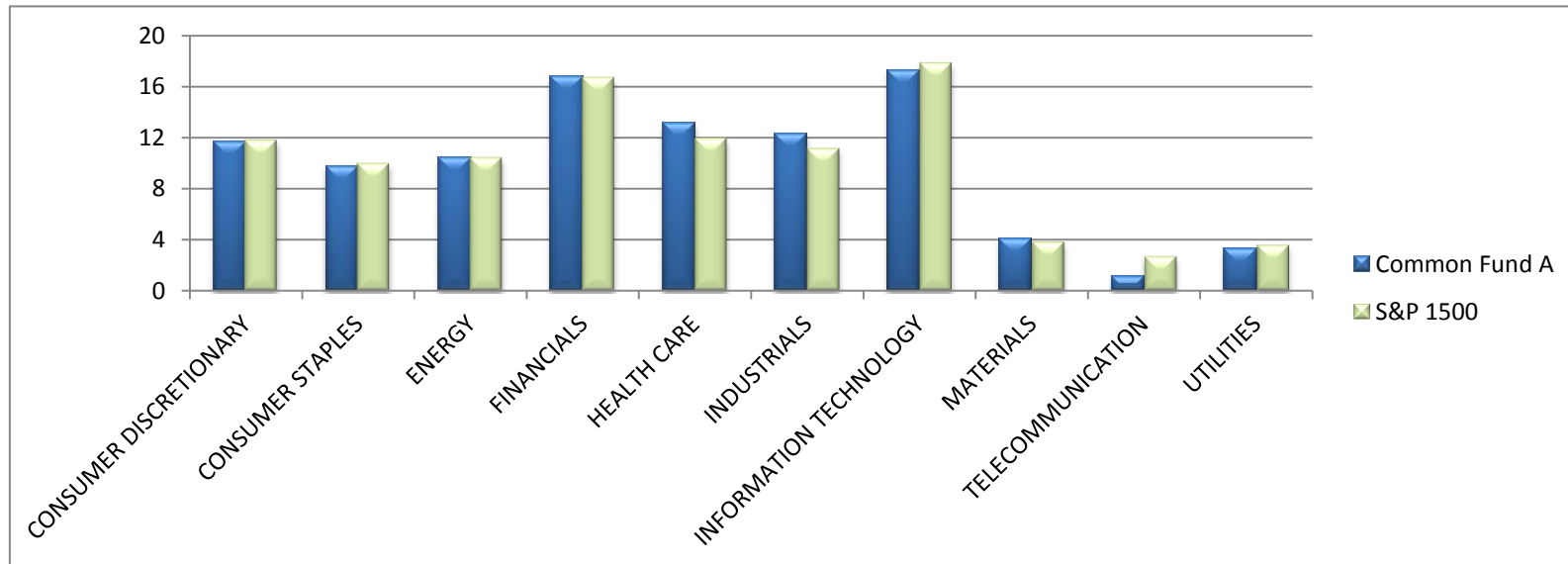

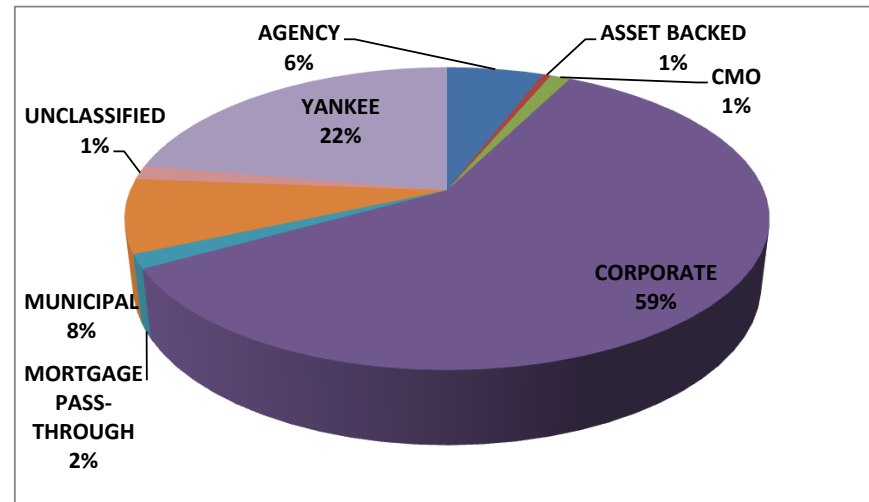

Sectors By %



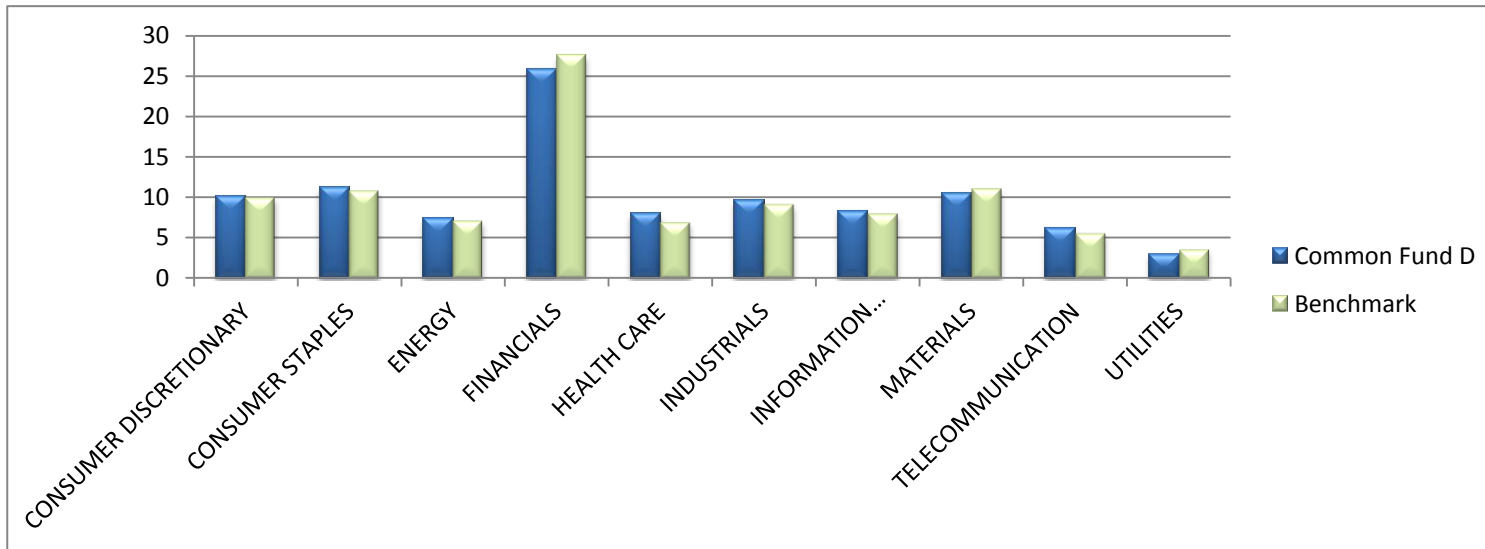

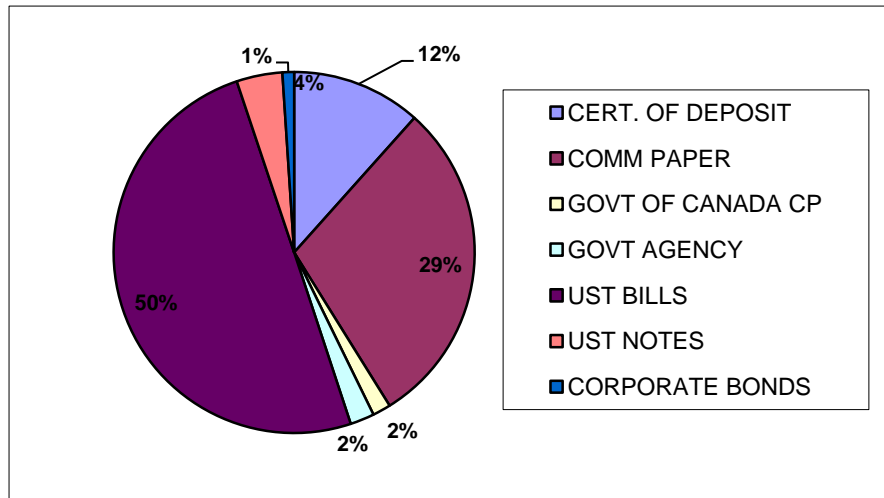
