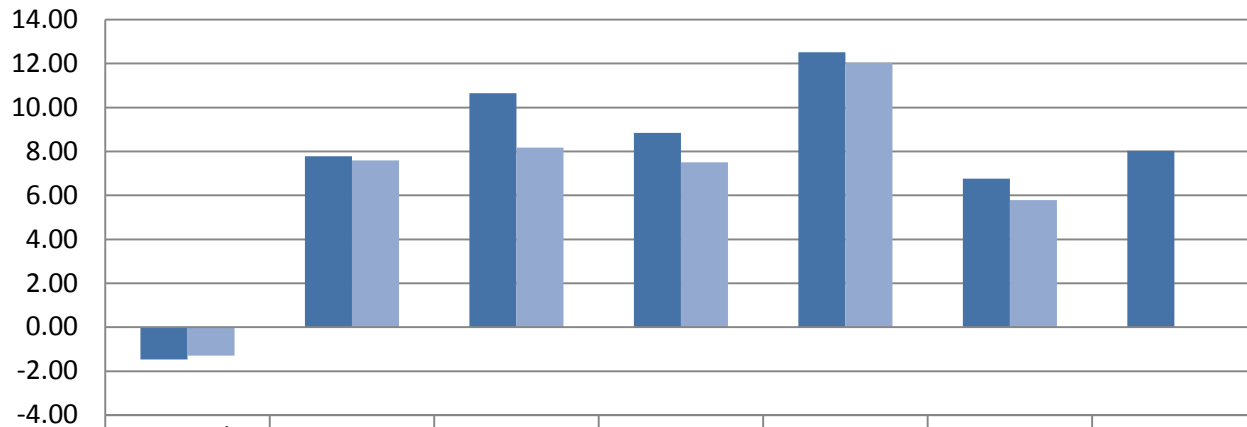

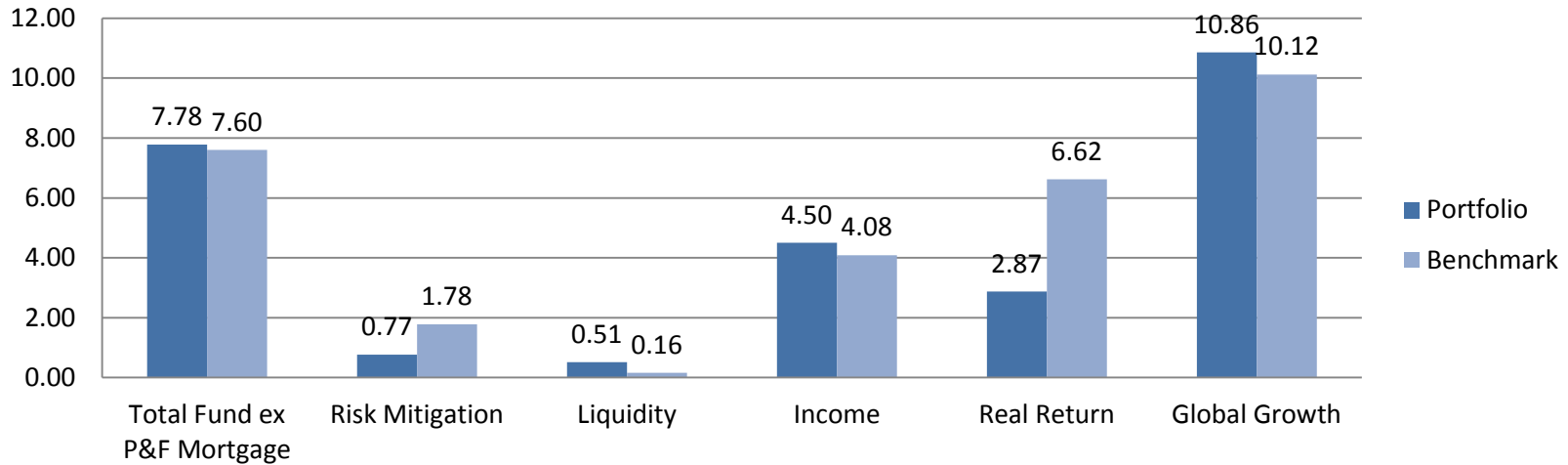
**Total Fund ex Police and Fire Mortgages as of 01/31/14**



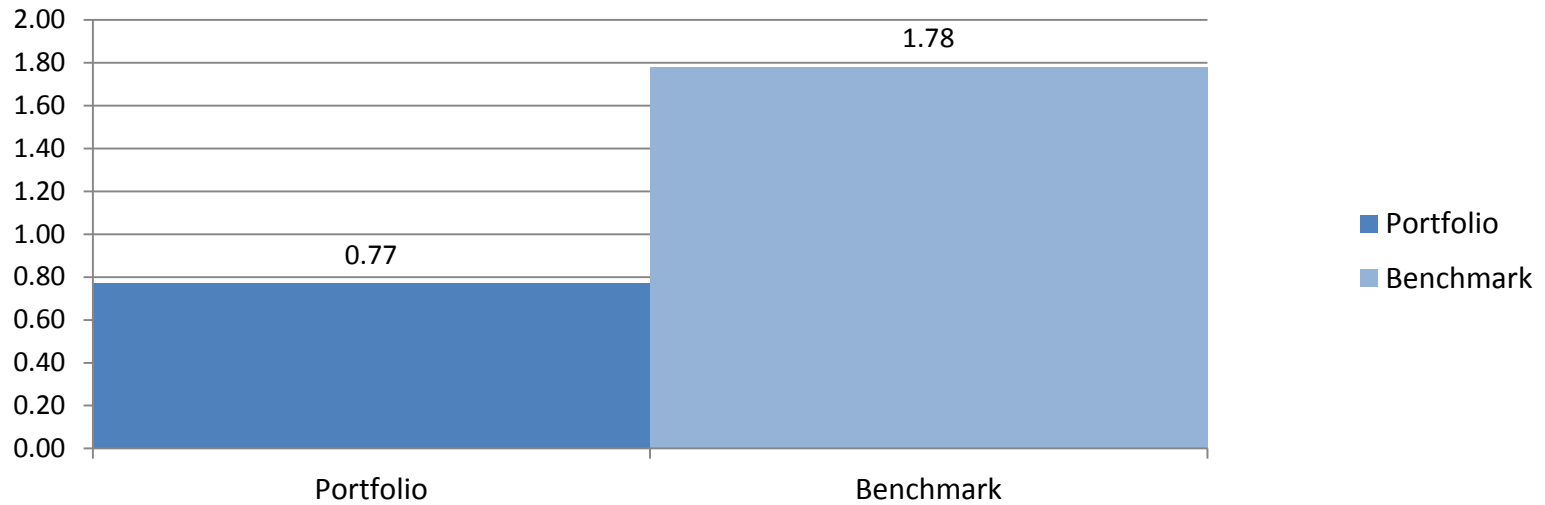

**FYTD Performance by Asset Class as of 01/31/14**

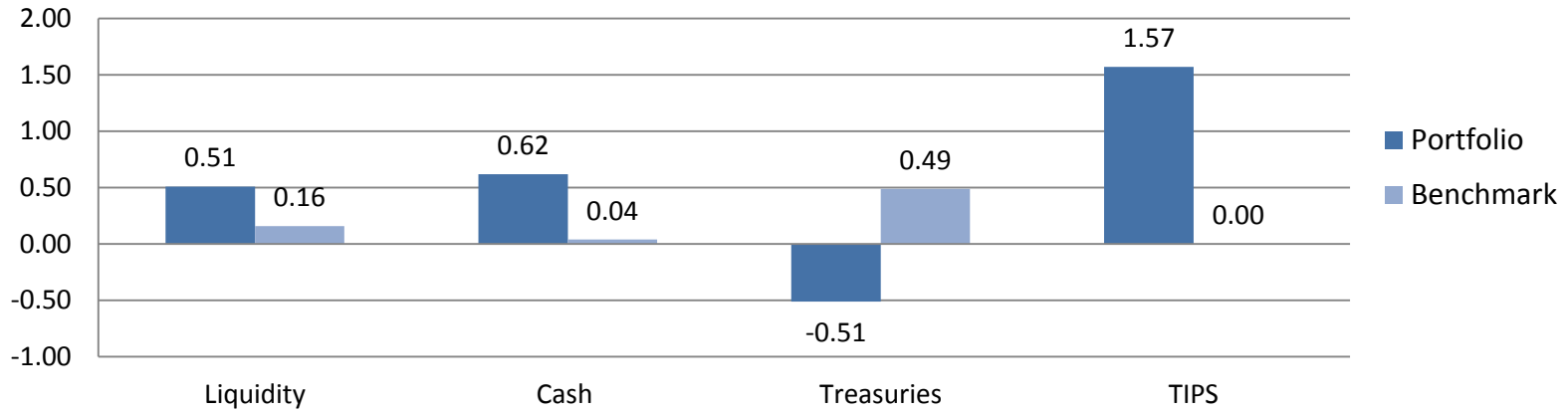


**FYTD Risk Mitigation Performance as of 01/31/14**

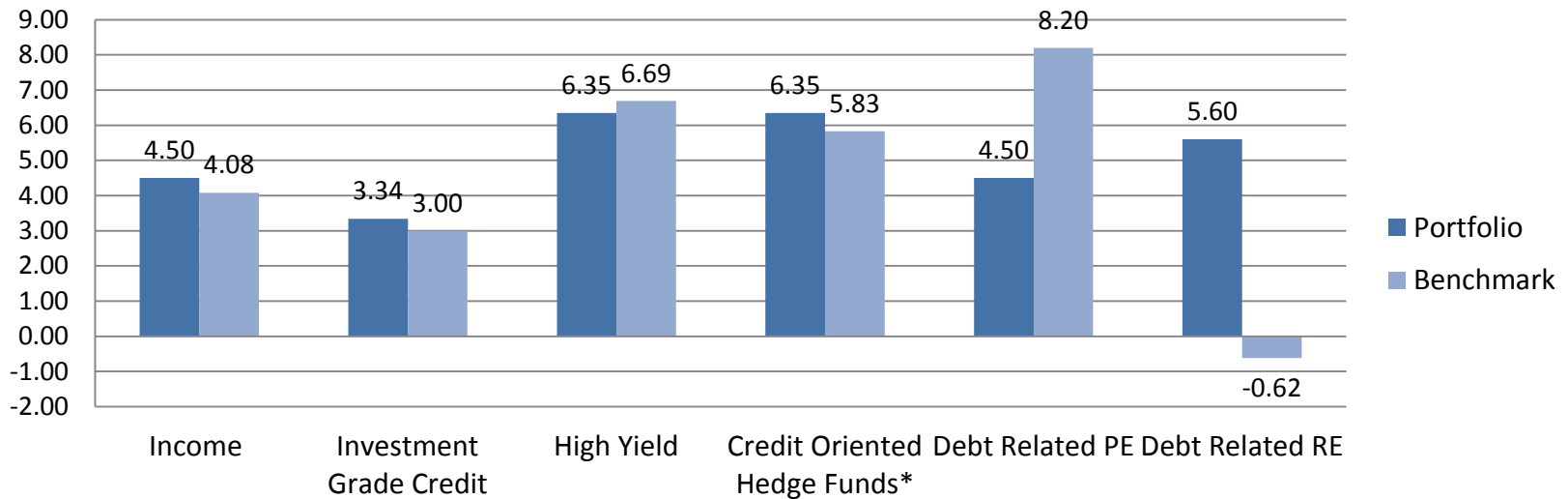

**FYTD Liquidity Performance as of 01/31/14**

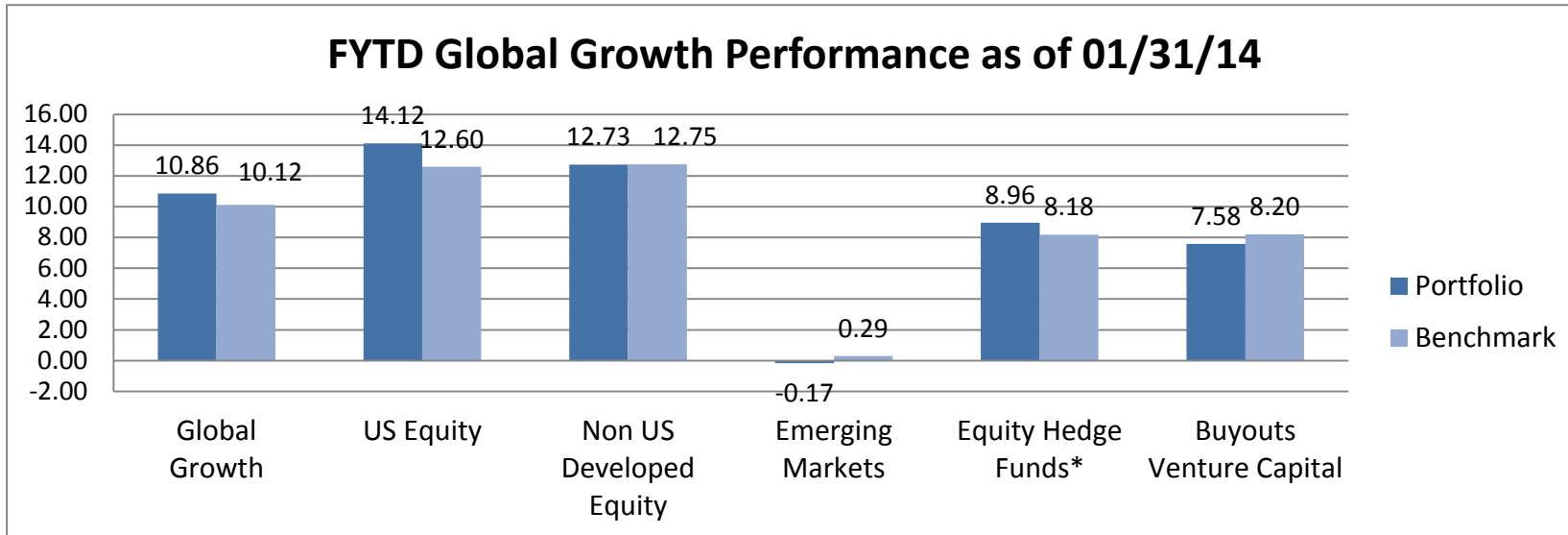
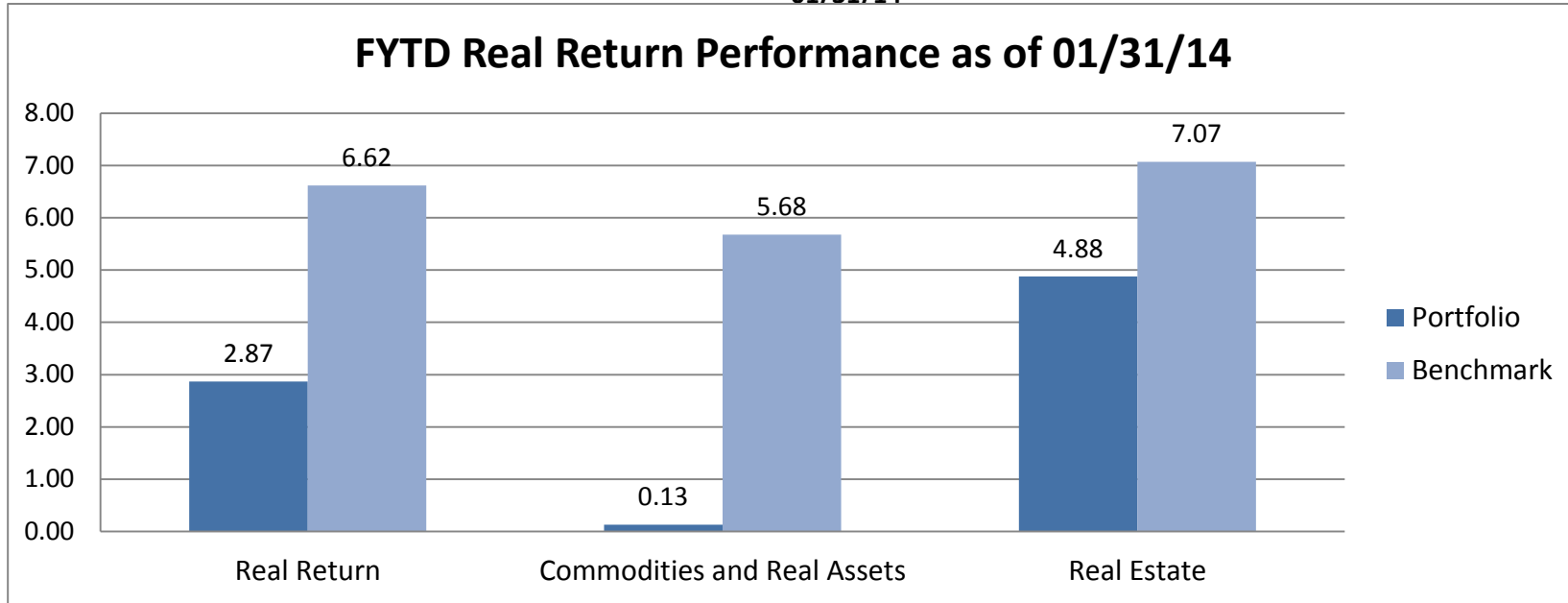


**FYTD Income Performance as of 01/31/14**

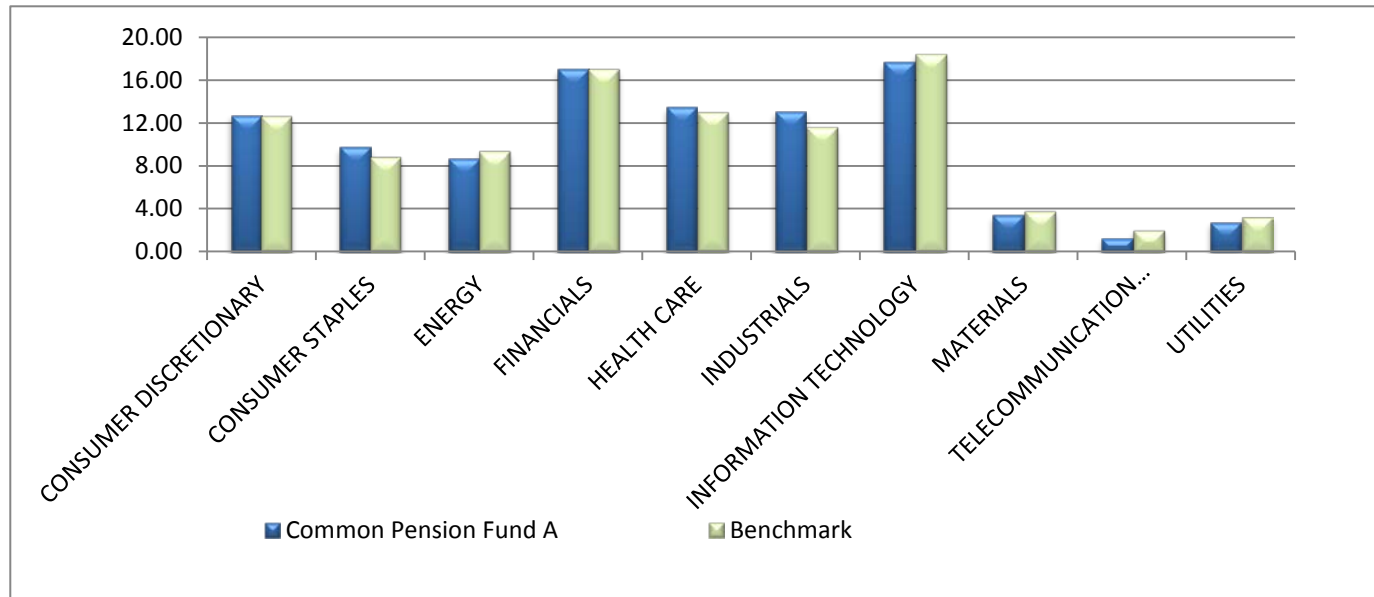

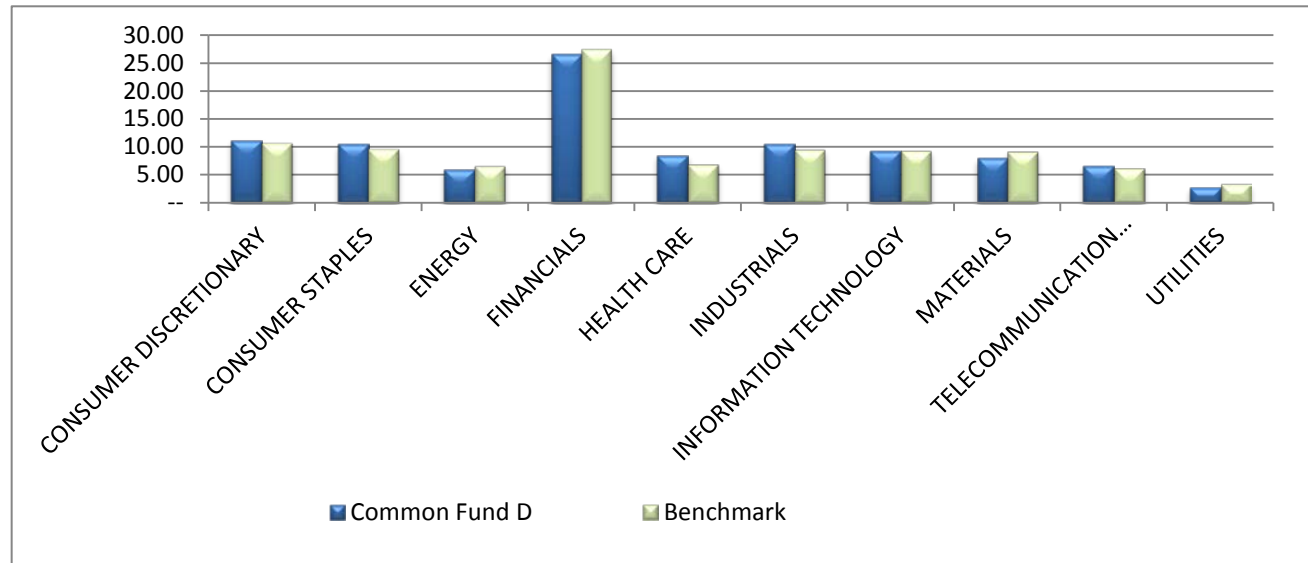
